The Elementary Discipline Matrix, compiled by the Administration, signifies the most common infractions committed by students. Notice that repeat offenses are accompanies by a progression of more serious disciplinary response than the original violation.

Every attempt will be made to follow the appropriate consequence outlined in the chart below. The Administration does reserve the right to determine the punishment based on the seriousness of a particular infraction and the previous discipline record of the student who commits the offense.
